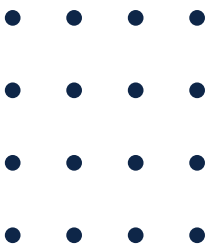

AEG in Action: Why Membership Matters Now More Than Ever



Bill C-59 – Current Update

Over the past year, AEG, in partnership with the Independent Contractors and Businesses Association (ICBA), led a targeted advocacy effort challenging provisions of Bill C-59 that posed a serious risk to freedom of expression and open public discourse for Alberta businesses.

With the support of legal counsel and direct financial contributions from AEG members and stakeholders, a constitutional challenge was launched to address these concerns. Throughout the process, AEG and ICBA worked closely with key stakeholders and government partners to underscore the importance of this issue to Alberta's business community and economy.

This effort delivered a clear and meaningful result. The federal government amended Bill C-59 by removing the provisions that were challenged. The lawsuit brought forward by AEG and ICBA was a catalyst for these changes, directly influencing the government's decision to revise the legislation and eliminating the need for further legal action.

This outcome is a significant advocacy win. It reflects the power of collaboration, member and stakeholder leadership, and principled action. AEG is proud to have stood alongside ICBA and our members to protect fundamental freedoms and ensure Alberta businesses continue to have a strong and credible voice in shaping public policy.
